## Official Terms & Conditions.

1. You, the buyer ("Buyer"), may cancel your purchase of this Pass and accompanying merchandise ("Purchase") at any time prior to midnight of the 5th business day of the Center after the date of this Purchase, excluding Sundays and Holidays. To cancel this Purchase, mail, email or deliver a signed and dated notice that states you are cancelling this Purchase, or words of similar effect. 2. This Two-Week Pass ("Pass") is good for a single, continuous two-week membership at Krav Maga Worldwide Los Angeles ("KMW") West LA and Sherman Oaks Training Centers.
3. The user of this Pass ("User") must be 14 years of age or older.
4. User must start two-week membership on or before 2/28/2025 by making an appointment with a memberships representative ("MR") and presenting this Pass to the MR upon arrival at either the West LA or Sherman Oaks Training Center.
5. User must sign a KMW waiver upon first check-in.
6. Pass must be presented at each check-in.
7. Pass is non-transferable once User starts two-week membership.
8. Pass is not valid for any (i) current member, (ii) former member whose membership was cancelled within last 30 days from date of purchase of Pass, or (iii) former member or buyer with an outstanding balance.
9. This Pass has no cash value and is not redeemable for cash.
10. **DESCRIPTION OF SERVICES, FACILITIES AND HOURS OF ACCESS.** This Pass entitles User to access the Center's premises during regular hours of operation for the following services and use of training equipment related to those services: Krav Maga (up to the level predetermined by KMW for User), KM Bag, Jiu-Jitsu, Weightlifting, and Strength & Conditioning. To enter the Center, User must present his/her Pass to check in at the Front Desk. Services may vary by location. KMW reserves the right to change the type or quantity of classes, services, or equipment offered, which changes are not grounds for cancellation. This Pass excludes personal training or other services not specifically identified above. **Facilities:** KMW has multiple locations. Facilities vary by location and may differ in the number of training rooms available, types of training equipment, availability of showers, as well as in other aspects not listed here. **Hours of Access:** Hours vary by location, which information may be found at [www.kravmagalosangeles.com](http://www.kravmagalosangeles.com). KMW may alter the Center's hours of operation.
11. **CANCELLATION.**
  - a. Cancellation upon death or disability. If User dies, becomes disabled or is unable to engage in all activities associated with his/her membership, the membership may be cancelled upon KMW's receipt of acceptable written verification from a licensed physician. In such circumstances, Buyer is relieved from any obligation of the Buyer to make payments for User's access, except those payments for which any service or product was provided prior to the date of death or onset of such disability.
  - b. Cancellation upon relocation. If User permanently moves his/her residence more than 25 miles from any Center that Member is entitled to use, membership may be cancelled upon KMW's prompt receipt of written verification of the move, which must be deemed acceptable proof by KMW. Buyer is relieved from any obligation of the Buyer to make payments, except those payments for which any service or product was provided prior KMW's receipt of the above referenced written verification of the move.
  - c. CA Civil Code §1812.85(b) right to cancellation within 5 days. Buyer may cancel his or her purchase of this Pass and accompanying merchandise at any time prior to midnight of the fifth business day of the Center (excluding Sundays and holidays) after the purchase date. To cancel this Purchase, mail or deliver a signed and dated notice, or

send an email stating you the consumer are canceling this Purchase, or words of similar effect.

- d. Cancellation of agreement of \$1,500.00 and over. Buyer may cancel his or her purchase of this Pass and accompanying merchandise under the following circumstances: (a) within 20 days after Purchase, if initiation and initial fees paid were \$1500 up through \$2000; (b) within 30 days after execution, if initiation and initial fees paid were \$2001 up through \$2500; (c) within 45 days after execution, if initiation and initial fees paid were greater than \$2,501. This section shall not apply to any Purchase that requires payment of \$1499.99 or less.

13. **LIMITED RECOVERY. ANY RECOVERY BY BUYER IN CONNECTION WITH THIS PURCHASE SHALL NOT EXCEED THE ACTUAL AMOUNTS PAID (IF ANY) BY BUYER.**

The terms above constitute the entire agreement in connection with this Purchase and supersedes any prior or contemporaneous representations, promises, or statements that are not otherwise stated herein. These terms may only be amended in a writing executed by both Buyer and an authorized KMW representative acting within the scope of their duties.
